2.0 Business

2.1 Bathurst and Bluenose-East Caribou Technical Working Group & Bathurst Caribou Joint Management Proposal Update

Bathurst & Bluenose-East Caribou Technical Working Group

The Minister of Environment & Natural Resources (ENR) invited First Nation leaders and wildlife management authorities to a meeting on Aug 27, 2014 to discuss the results from the 2014 reconnaissance surveys for the Bathurst and Bluenose-East Caribou herds, which suggest a marked decline in the number of breeding females on the calving grounds. The Bathurst and Bluenose-East Caribou Technical Working Group met Oct 9-10, 2014 and Oct 22-23, 2014. A list of recommended actions was developed and refined for review by leadership. The Minister of ENR, First Nation leaders and wildlife management authorities

met on Nov 7 & 28, 2014 to review and discuss the recommendations of the Technical Working Group. No consensus decision was reached on which management actions to implement in 2014/2015 for either herd.

ACCWM Recommendations

The ACCWM submitted the "Taking Care of Caribou: The Cape Bathurst, Bluenose West and Bluenose East Barren-ground Caribou Herds Management Plan" to GNWT and other governments on Nov 5, 2014. As well, the ACCWM provided recommendations regarding the Bluenose-East Caribou herd to the Minister of ENR on Nov 5, 2014, Nov 19, 2014, and Dec 4, 2014, with the primary recommendation being that, during the 2014/2015 harvest season, the existing voluntary harvest target of 2800 Bluenose-East Caribou (NWT overall harvest of 1800 caribou) continues with a focus on a majority bulls harvest, emphasizing younger and smaller bulls and not the larger breeders and leaders. If ENR has evidence to suggest that the harvest target has been exceeded by 10% or more for the 2014/2015 harvest season, then, after consultation with the ACCWM, regulations should be put in place to close harvesting in areas occupied by the Bluenose-East Caribou herd.

The Minister of ENR replied on Dec 17, 2014 accepting the interim recommendations of the ACCWM with a request to vary the overall NWT harvest target of 1800 Bluenose-East Caribou to $1500 \pm 10\%$, with 80% of the harvest being bulls. The ACCWM replied on Jan 9, 2015 requesting that its previous harvest recommendation be implemented.

Bathurst Caribou Joint Management Proposal

On Jun 30, 2014, ENR and Tłįchǫ Government (TG) submitted a joint management proposal, entitled "Joint Proposal on Caribou Management Actions in Wek'èezhìi: 2014 – 2019". The Board informed ENR and TG on Jul 11, 2014 that the joint management proposal was deemed incomplete until receipt of consultation reports from both governments. To date, both consultation reports remain outstanding.

On Sep 15, 2014, the ENR and TG requested that the WRRB defer consideration of the joint management proposal to allow the two governments to review the new information about the Bathurst Caribou herd and determine whether the management actions suggested are still appropriate. The WRRB accepted receipt of the letter on Oct 17, 2014, as well as reminding ENR and TG about Tłįcho Agreement requirements and the Bluenose Caribou Herds management plan.

2.2 Wildlife Research Permit Application – Monitoring of Bathurst and Bluenose-East Caribou Herd

Wildlife Research Permit (WRP) Application, entitled "Monitoring of the Bathurst and Bluenose-East Caribou Herds", tabled

The WRP application requests support for the following monitoring actions:

- The use of satellite collars to monitor the movement and distribution of migrating caribou on a weekly basis. For that purpose, ENR plans to deploy in February-March 2015 and maintain up to:
 - a. 50 collars on the Bathurst herd (30 on cows and 20 on bulls).
 - b. 50 collars on the Bluenose East herd (30 on cows and 20 on bulls);

- 2. The late winter calf survival / spring recruitment survey (in March-April 2015) to measure annual calf survival for the Bathurst and Bluenose-East caribou and compare herd trends; and,
- 3. The fall sex-ratio survey in mid-October 2015 to assess the ratio of bulls to cow in the herd, and to extrapolate the total population estimate when a calving ground photographic survey is conducted.

Although elders do not support collars, with Tłįchǫ Government support and the requirement for additional information, the Members agreed to support the application.

2.3 NWT Species at Risk Committee Membership & Update, Moise Rabesca

The most recent Species at Risk Committee (SARC) meeting took place in Ft. Simpson in December 2014 and Moise Rabesca and Boyan Tracz both attended. The Conference of Management Authorities (CMA) approved amendments to the Assessment Schedule, moving barren-ground caribou to 2016.

A decision was made to approve Status Report for Wolverine in the NWT, with minor edits discussed. A discussion of the assessment of Wolverine occurred, and a decision was made to assess wolverine as Not at Risk in the NWT. A decision was made to approve the Status Report for Western Toad in the NWT. A discussion of the assessment of the Western Toad occurred, and a decision was made to assess western toad as Threatened in the NWT.

The NWT Species at Risk Secretariat informed SARC members that many appointments will be expiring in March 2015, including Moise Rabesca. Moise expressed interest in renewing his appointment.

2.4 NWT Conference of Management Authorities – Assessment, Listing and Management Planning for Lesser Known Species & Update

During an in-camera session at the June 2014 Conference of Management Authorities (CMA) meeting, the Management Authorities were asked the following: "Do you support assessing, listing and doing management planning for species at risk that are of lesser interest or might be considered lower priority?" They might be of lesser interest because NWT residents don't care very much about them (e.g. if they are not harvested), or because they are not very well known (e.g. we don't have a lot of information about them), or because there seems to be little we can do to manage them. Examples of lesser known species include: Drummond bluebell, Banks Island alkali grass, bumble bees, collared pika and bats.

The Board acknowledges the importance of an ecosystem approach and, as such, that all species are connected. Therefore, the Members recommended that the decision about assessing lesser know species is done on a case-by-case basis. Where lesser know species have been assessed, consultation requirements for listing and management planning will be deferred to GNWT.

2.5 Wood Bison Recovery Strategy & Species at Risk Update/Listings, Dawn Andrews, Environment Canada

Proposed Listings

In November 2013 and May 2014, COSEWIC (Committee on the Status of Endangered Wildlife in Canada) assessed several species. The following assessed terrestrial species are found within Wek'èezhìı:

- \bullet Wood Bison (*Bison bison athabascae*) Re-assessment previously Threatened, now Special Concern 2013
- Wolverine (*Gulo gulo*); Western population Re-assessment Confirmed Special Concern 2014
- Gypsy Cuckoo Bumble Bee (Bombus bohemicus) New Endangered 2014

On December 22, 2014, a consultation package was sent out to communities asking for their input into the proposed listing of the three species found within Wek'èezhìi; this material was also sent to the Tłįchǫ Government and the WRRB. The Board is requested to approve the proposed listings.

Short-eared Owl Management Plan

The Short-eared Owl was assessed as Special Concern under the federal *Species at Risk Act*; therefore, a management plan is required. A first jurisdictional review of the document was completed by the WRRB in February 2014. A second jurisdictional review is now required along with a request for approval and support to post the recovery strategy on the Species at Risk Public Registry for a 60-day public comment period. The Board is requested to approve the posting of the management plan to the public registry.

Wood Bison Recovery Strategy

Even though COSEWIC has most recently assessed the Wood Bison as Special Concern, its status under the federal *Species at Risk Act* remains Threatened and a recovery strategy is required. On January 6, 2015, the WRRB and Tłįchǫ Government were sent the draft recovery strategy for a jurisdictional technical review, which is due on February 11, 2015. The Board is requested to provide input on the draft recovery strategy and advice on Tłįchǫ communities to be consulted.

<u>Little Brown Myotis Recovery Strategy</u>

The Little Brown Myotis is a mammal that was emergency-listed as Endangered under the federal *Species at Risk Act* in November 2014; therefore, the recovery strategy will be due in November 2015. Environment Canada staff are in the early stages of developing a recovery strategy for the Little Brown Myotis, which governments, wildlife management boards, and communities within the range will receive. The Board is requested to provide input on the draft recovery once available.

2.6 Tłicho Wildlife Research Workshop

On Feb 20-21, 2013, the Tłįchǫ Wildlife Research Workshop was held in Gamètì, NT. The purpose of the Workshop was to 1) solicit advice from both Tłįchǫ communities and scientists, 2) provide an opportunity for Tłįchǫ communities and scientists to share information, and 3) develop a sense of ownership in research and management planning activities. The WRRB partnered with the Tłįchǫ Lands Protection Department, Wek'èezhìi Land & Water Board, and Environment & Natural Resources, Government of the Northwest Territories to ensure fulsome discussions occurred.

Staff is interested in making the Tłįchǫ Wildlife Research Workshop a bi-annual event, i.e. the workshop would be held every two years in a Tłįchǫ community. Previous partners would be approached to determine their interest and seek ideas on themes for discussion. Funding or in-kind support would be sought from the GNWT, TG, WLWB and the WRRB's Wildlife Studies Fund.
