2.0 Business

2.1 Review GNWT and TG's Joint Proposal on Management Actions for Wolves (dìga) on the Bathurst and Bluenose-East Barren-ground Caribou (?ekwò) Herd Winter Ranges: 2021-2024

In January 2020, ENR and TG developed a proposal for diga management. In March 2020, the WRRB approved a Pilot program for the winter of 2020, and requested ENR and TG submit a revised joint management proposal on August 21, 2020, based on the learnings from the Pilot program.

On August 25, 2020, the GNWT and TG submitted the revised GNWT and TG "Joint Proposal on Management Actions for Wolves (Diga) on the Kǫk'èetì ekwǫ and Sahtì ekwǫ Barren-ground Caribou (Ekwǫ) Herd Winter Ranges: 2021 – 2024". A 2020 Diga Management Pilot Program Technical Report (August 21, 2020 in the digital binder) was submitted to describe and analyze the work completed to-date. The 2020 Pilot program consisted of enhanced support for diga harvesters, monitoring, and aerial diga reduction actions.

The 5-year proposal uses learnings from the 2020 Pilot program (year 1) and outlines a range of actions to manage wolves, specifically: 1) Enhanced support for diga harvesters and the traditional economy; 2) Aerial diga reduction actions (if required) to reach removal targets; and, 3) Monitoring, research, and assessment.

2.2 Review and Approval of Wildlife Research Permit Application – Wolf Collaring on the Central Barrens, Amendment

On January 8, 2020, the Department of Environment and Natural Resources (ENR) submitted a Wildlife Research Permit application for collaring 30 *Diga* (wolf) on ranges of the *Kộk'èetì* (Bathurst) and *Sahtì* (Bluenose East), and Beverly *Ekwò* (barren-ground caribou) herds. The WRRB did not support this Wildlife Research Permit as the Board was then unable to undertake the process of reviewing and providing recommendations on the *Dìga* Joint Management Proposal, which it is closely tied.

ENR issued themselves Wildlife Research Permit #WL500830 for the *Diga* collaring program outlined in the January 8 application. ENR can issue Wildlife Research Permits without the Board's approval. A *Diga* collaring program occurred in early 2020. On June 24, 2020, ENR submitted an amendment to Wildlife Research Permit #WL500830, in the form of an updated Wildlife Research Permit Application.

The amended Wildlife Research Permit application includes the following main changes from the January 8th application: 1) Flexibility to also deploy GPS collars on wolves during other months of the year, including June, late summer, and fall; 2) the option to also use chemical immobilization, in addition to net-gunning, for the capture of *Diga*; and, 3) the option of occasionally setting up trail cameras at den sites, in order to assess pup production.

2.3 Review and Approval of Proposed Increase to the Total Allowable Harvest for the Mackenzie Bison Herd

Harvest on the Mackenzie wood bison population was closed in 2012 after an anthrax outbreak killed at least 450 bison. The population declined from 1550 to 740 (2013 estimate). In 2016, the population was estimated at 851 and, in 2019, at 1468. This indicates an average annual population growth rate of 13% since 2013.

The Mackenzie Bison Working Group (MBWG) recommended that ENR reopen harvesting of a limited number of male bison from the Mackenzie wood bison population, based off of the harvesting plan within *the Mackenzie Bison Management* Plan and the *Recovery Strategy for Wood Bison* (Bison bison athabascae) *in the Northwest Territories*. The harvesting plan outlines harvest of between 1-3% when the population is between 1000-1500 animals, and harvest of between 2-3% when the population is between 1500-2000 animals.

On August 10, 2020, ENR submitted a management proposal to the WRRB to amend the Big Game Hunting Regulations under the Wildlife Act to reopen harvesting opportunities on wood bison in the Mackenzie population. The management proposal includes the following: 1) Timeframe: Fall 2020 until March 31, 2024 (4 years); 2) 40 male bison harvest only; 3) all harvesters required to have a tag to hunt bison; and, 4) Initial allocation to communities/management authorities based on MBWG recommendations. Harvest allocation to be revisited by MBWG before March 31, 2024.

2.4 Review and Approval of Amendments to the Mobile Core Bathurst Caribou (Kộk'èetì Ekwộ) Management Zone Regulations

The Mobile Core Bathurst Caribou Management Zone Regulations identifies a wildlife management area that prohibits all hunting of barren-ground caribou under the Wildlife Act to help conserve the Bathurst caribou herd. The Mobile Zone changes weekly and is based on collared caribou information. To date, the Mobile Zone has never overlapped with other ecotypes of caribou, such as boreal caribou. However, GNWT must ensure that the zone can be applied wherever it is needed and apply to any type of caribou found within it.

As such, GNWT is requesting to change the current regulation by removing the term "barren-ground" from Sections 1, 2(1), and 2(2). This change will ensure that the regulation will apply to all types of caribou. GNWT feels this will maximize conservation protection efforts and affirm commitments to do everything possible for the Bathurst caribou herd.

2.5 Review and Approval of NWT General Status Ranking Program – Batch 4 & 5

Batch 4

Batch 4 has been provided to the Board for review and approval. Batch four includes vesper wasps, sponges, corals, marine decapods, sea urchins, sea cucumbers, ants, spiders, mayflies, stoneflies, and lacewings. Photos of species in these categories are included at the end of this briefing note. There are 16 ant species, 10 coral species, 24 lacewing species, 20 marine decapod species, 85 mayfly species, 9 sea cucumber species, 3 sea urchin species, 323 spider species, 8 sponge species, 38 stonefly species, and 24 vespid wasp species. Rankings of the species are varied. Batch 4 approvals were required by June 15, 2020; as such, the Staff provided a letter of support in principle on May 27, 2020.

There are 5 amphibian species, 47 bird species, 14 damselfly species, 36 dragonfly species, 12 marine mammal species, 1 reptile species, and 76 terrestrial mammal species. 2.6 Review and Approval to Post Draft Red-necked Phalarope Management Plan, Carine Cote-Germain, ECCC

Under the Species at Risk Act (SARA), a management plan must be developed f or each species listed as Special Concern in order to identify measures for the conservation of the species. The main threats facing the Red-necked Phalarope are: 1) Breeding habitat degradation from threats like development and climate change, and 2) Breeding ground and nest disturbances by exploration and development. The main management objective is to achieve a stable or increasing population trend, measured over a period of 10 years, by 2040. ECCC did not receive any consultation responses.

2.7 Review and Approval of Proposed Timeline Change for the Wek'èezhìı Boreal Caribou Range Plan

Measure 6-1, Part 1 of the Environmental Assessment for the Tłլchǫ All Season Road (TASR) project (EA1617-01) states that "GNWT-ENR will complete and submit a range plan ... to the Wek'èezhìı Renewable Resources Board for review under section 12.5.1 of the Tłլchǫ Agreement a minimum of 90 days before the Project is opened for public use". However, since the date the measure was accepted, the timeline for completion of the TASR was accelerated by almost two years, which does not allow for enough time for GNWT to complete the plan. Additionally, COVID-19 restrictions have delayed community meetings to gather Indigenous Knowledge. The GNWT cannot request to modify the timeline in the measure once the responsible ministers have adopted the Mackenzie Valley Environmental Impact Review Board's recommendations with modifications.

The GNWT is proposing to submit an "interim" boreal caribou range plan for the Wek'èezhìı to the WRRB a minimum of 90 days before the TASR is open to the public. The interim plan would use currently available Indigenous knowledge only. The interim plan would only be in effect for two years while the GNWT continues to develop a complete range plan, including full consideration of the Indigenous knowledge collected at community meetings. This final range plan would be submitted to the WRRB as a management proposal under Section 12.5.1 of the Tłycho Agreement, approximately two year after the interim proposal is submitted.

Board staff have consulted with legal counsel to review the Board's authority related to the original Measure 6-1, Part 1.

Starting March 18, 2020, due to the Covid-19 pandemic, the WRRB office closed its doors and staff began working from home to reduce risk of exposure to Covid-19. McLennan Ross LLP recommended that all businesses and organizations prepare a pandemic response policy to provide direction to staff.

Following legal review, the Board was provided the final draft copy of the Pandemic Response Policy on March 19, 2020. All contractors were canceled as of March 19, 2020 until further notice. Additional wording added to ensure that the policy can be used during current pandemic as well as in the future.

4.2 Review and Approval of Exposure Control Plan

On May 15, 2020, the GNWT published its *Emerging Wisely Response Plan*, which identifies that 25 people are allowed indoors so long as adequate protocols are implemented to reduce the risk of transmission of Covid-19. Workers' Safety and Compensation Commission (WSCC) requires employers to have an *Exposure Control Plan* in place that looks at the risk of COVID-19 transmission in their workplace.

A Workplace Risk Assessment and individual Worker Hazard Assessments were completed. Using the completed assessments, a draft Exposure Control Plan was created. The Plan outlines how employers, supervisors, and workers will eliminate or control the risk of Covid-19 exposure at work. The final draft Exposure Control Plan was reviewed by legal counsel and shared with Board Members on July 10, 2020. Staff returned to the office, starting August 5, 2020 (three days in office, two days at home). The office will remain closed to the public until Phase 4 (vaccine available).

4.3 Proposed Revisions to the Rule for Management Proposals

The Rule for Management Proposals is a document used to provide guidance to any person or organization making an application to the Board or required to consult the Board, including Parties to the Tłįcho Agreement. The Rule for Management Proposals was last approved on October 16, 2018.

Staff have been working with John Donihee, Legal Counsel, to revise and expand the current Rule to better include proposals for forest, plants, and protected areas in addition to wildlife as well as provide more clarity and consistency throughout the document. Once a final draft is available, the Rule will be sent to Parties of the Tłįcho Agreement as per Section 6 of the Rule, which identifies that the Rule will be reviewed at three-year intervals. Following input from the Parties, the Rule will be brought to the Board for final review and approval

4.4 Review and Approval of Proposed Website Upgrades

The WRRB's website is created and managed using a software called Drupal. The current version of Drupal no longer offers the support needed to maintain the website. Outcrop manages and provides technical support for the WRRB's website.

Board Staff has discussed with Outcrop the process of upgrading to the newest version of Drupal to ensure that the website continues to be supported and user-friendly. Outcrop has provided a technical analysis and breakdown of what is needed to upgrade the website along with a quote.
