

To Whom it May Concern:

Re: Research permits and land use permits application.

On June 7, 2007 the Lutsel K'e Dene 1st Nation (LKDFN)'s Wildlife, Lands and Environmental Committee (WLEC) met and recommended to the LDKFN Council that no approval be given on any permits till several protocols are met. The LKDFN-WLEC has been overwhelmed with resource development activities in our territory which has prompted paper overload. The LKDFN doesn't have the capacity or financial resources to deal with all paperwork. The LKDFN has a consensus decision making process. Typically, this process requires comprehension of research/land use application, translation, debate/discussion stages which leads to a decision. This process has some exceptions for university researchers only.

Following are our interim protocols till further notice:

The first protocol is to have a meeting with the researcher/applicant in the community prior to the filing of a research/land use application or immediately upon filing of a research/land use application.

- This meeting is to include full disclosure of the company's Audit Report & Financial Statement including Board of Directors.
- Deliver a visual presentation to the community on the application

The second protocol is to cover the full cost of all meetings. (Draft meeting budget cost attached.)

The third protocol is to cover the cost of the translation requirements. LKDFN is a Dene Yati community of Denesoline Dene (Chipewyan).

The fourth protocol is to have frequent site visits of community groups to the area of interest.

The fifth protocol is to employ and train our LKDFN members in the research/land use application operations.

The sixth protocol is to have frequent operations reporting visits to the community.

The seventh protocol is to have the LKDFN Elders visit the site for information or educational meetings.

The eighth protocol is to implement the LKDFN traditional knowledge in the research/land use application operations. LKDFN is to be the contractor.

The ninth protocol is to use our various companies in providing service to the research/land use operations.

The tenth protocol is to contribute to the LKDFN scholarship fund.

The eleventh protocol is to contribute \$30,000 to the LKDFN to commence the interim protocols.

The twelfth protocol is to contribute funds to a researcher/land use applicant Laison Worker.
