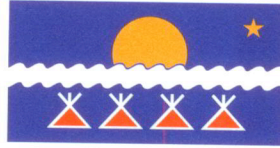


Ms. Snortland,

Following the March 22-26, 2010 Bathurst Caribou public Hearing, the WRRB gave the Tłı̨chǫ Government and ENR an adjournment. This adjournment was given with the expectation that the two parties would go back to the table and work together in an attempt to resolve any differences that existed in the original proposal submitted on November 5, 2009, namely issues 4 and 5.

Since the adjournment, the Tłı̨chǫ Government and ENR have worked together in 2 sessions - one held April 13-16 and another held April 27,28. We will hold one more session on May 11-12, 2010. The two parties feel they have made significant progress on the issues at hand.

We will be submitting the progress report in partnership, as indicated by ENR. We do ask that in order to ensure the confidentiality and continued progress on the management proposal, the summary documents and outline are kept confidential and off the public registry.

Adjournment Progress Report to Wek'eezhii Renewable Resources Board

This progress report is provided to the Weke'ezhii Renewable Resources Board (WRRB) to comply with the following conditions of the Board's March 26, 2010 WRRB Adjournment Ruling:

1. The Tlicho Government and Environment and Natural Resources (ENR) must provide an interim report on progress by April 30, 2010.
2. This report shall include a summary of consultations conducted with other parties and sufficient detail to enable the Board to determine whether substantial progress has been made.
3. Board staff and independent expert will participate in the process as observers and report to the Board on an ongoing basis.
4. The Board expects that any new proposal filed by May 31, 2010 will address:
 - a. Harvest numbers
 - b. Allocation of harvest for both Bathurst and Bluenose-East Caribou within Wek'eezhii Management Area.

The Tlicho Government and ENR met on April 13-15 and April 27-28 and have another meeting scheduled for May 11-12. Summaries of both meetings are attached so that the board may assess progress to date. Board staff have participated in both meetings and will report to the board. However, it is expected that board staff will respect the confidential nature of these meetings between both governments.

An outline for the new proposal to be submitted by May 31, 2010 to the Board is attached. This may be revised at the May 11-12 meeting.

Currently, the new proposal will address the following components of the joint proposal submitted by the two governments in early November 2009 to the Board:

1. Management actions 4 and 5 in Appendix A
2. Monitoring actions 1-8 in Appendix B will be incorporated into the adaptive management framework.

The new proposal will contain the following new components that address issues raised at the public hearing:

1. Predator management – this expands on the actions identified in ENR's presentation at the public hearing
2. Increased access to wood bison in Wek'eezhii to reduce pressure on caribou – this expands on actions identified in ENR's presentation at the public hearing

3. Monitoring actions for other harvested species such as moose or woodland caribou
4. Capacity and governance
5. Social and cultural relationships

As discussions between the two governments have not been completed and are confidential, it is requested that the Board not distribute the summaries from the two meetings and the outline for the new proposal.

As requested by the Board, ENR is reporting on consultations with the following intervenors and organizations:
