Please read the following carefully.

Intervenor Status

WRRB held a board meeting with quorum on November 19, 2009 to review the 16 intervenor registration applications received by the November 18, 2009 midnight deadline. The Board considered fair and equitable treatment for all persons who requested intervenor status.

After reviewing the applications a motion was passed:

An individual intervening on behalf of his or her self or a corporation or an organization may appear as an intervenor only once at the public hearing.

Clarification

If one person is intervening as an individual that same person cannot take part as a member of an intervenor panel at the hearing. If a person is intervening on behalf of a group or organization, that person cannot intervene at the hearing as an individual or on behalf of another group or organization in another intervention.

Any intervenor may:

- a) arrange for another person to replace them in their individual intervention and take part in any one intervenor panel;
- b) withdraw from all panels to present their individual intervention;
- c) arrange for another person to replace him or her on any panel(s); or
- d) combine with other intervenors to form one intervention at the hearing.

Note: The main point is that any one person appears only once as an intervenor at the public hearing in any capacity.

For those of you who have completed a registration form or are listed on any registration form as an individual or as a member of a group intervention more than once, please examine your particular circumstances and notify me. Any person coordinating a group intervention should contact me confirming their group decision no later than **November 26, 2009**.

Those of you who are noted on one intervention registration form only, there is no need for any action on your part except to meet deadlines in the Public Notice on our website.
