Re: Caribou hearings: Disclosure

As you have suggested, we have included a preliminary list of all documents that we would like disclosed for this hearing. All of the documents are relevant for numerous reasons including the nature and size of the Bathurst herd, nature and size of other herds, decline asserted by ENR, caribou management, wildlife management, independent decision making etc.

We note that the harvest by some groups may target herds other than the Bathurst. It is important to know the distribution of harvest relative to the distribution of the herds as determined by collared caribou by ENR. We also note that the locations of collared caribou have been used to justify the closing of the hunt over a large area to protect the Bathurst caribou, even though at least 2 or 3 other herds also use the Wek'eezhi area at some times of the year. Detailed examination of the movements of collared caribou may indicate closure is unnecessary.

We note that the time-lines to respond to the WRRB's request of June 15, 2010 (ie 3 days with responses due by June 18, 2010) were extremely tight and did not allow sufficient time for us to produce a complete list of documents. This would require going through all ENR and Tlicho documents on the WRRB website to identify all of the documents such as those that are "in press" or "in draft" etc. It

would also require going through the New Revised Joint Caribou proposal, which is quite an onerous task given its size and information. The time frame prescribed by the WRRB was not sufficient to do this.

We believe that ENR and the Tlicho should be disclosing everything that is in their possession that is any way related to caribou and wildlife management, whether it supports their position or not. We have noted some of the documents below. We reserve our right to review the documents that are disclosed pursuant to your letter of June 15, 2010 and to request any additional documents that may be important to this hearing or that may arise from our review of these documents.

Documents Requested for Caribou Hearings

Surveys

- all surveys including the draft 2009 Bathurst Caribou Survey which has not been finalized, yet a hearing has been held on same and emergency measures taken on a draft survey-apparently this document is still not for general public distribution
- all drafts of this survey prior to the final draft report
- all information related to the exclusion of 2/11 caribou in the June 2009 survey including all internal correspondence, notes, emails etc
- reasons as to what happened to the other 9 caribou that ENR had on the Bathurst Animals (had a total of 20 collared animals)- decisions were made and emergency action take in June 2009 based on 9 animals out of 32, 000 when Alberta Research Council said sample sizes of 20 were too low to draw conclusions!
