Thank you for your letter dated November 16, 2009 concerning your request for information in regards to the Joint Proposal on Caribou Management Actions in Wek'èezhì. This proposal was submitted by the Tłıchō Government and the Department of Environment and Natural Resources (ENR), Government of the Northwest Territories (GNWT).

At this time in the season, our senior TK researcher and others in the department are extremely busy. Therefore we would like to request an extension until December 18, in order to ensure that we can answer all of your requests with the greatest consideration and certainty. The Caribou are of the utmost importance to the health, livelihoods and well being of the Tłıchō people in the past, present and future, and the Traditional Knowledge requests in particular require time and reflection to answer.

In response to your request for permission to put two documents: *Caribou Monitoring and the State of their Habitat*; and *Monitoring the Relationship between People and Caribou* on the public registry, the Tłıchō Government supports this request.

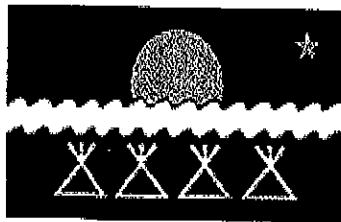
