Dear WRRB,

I would urge the WRRB to take as much time, and to investigate as deeply as possible, the information it is receiving from ENR. This is an unfortunate role the WRRB has been placed in, one for which it was never intended, and for which its members were never trained. Acting in the public interest, does not necessarily equate to acting in concert with ENR. Additionally, using the best available science, which, by law, is provided by ENR, does not necessarily equate to agreeing with ENR's interpretation of that science, which is clearly politically motivated.

To the holdover board members from the 2007 hearings, ask yourself: "What happened to the scientific approach to game management? What happened to the 4% management harvest goal put forth in 2006? What happened to being told wolf numbers were very low? What happened to all the caribou being harvested in Wek'heezhi (5774) being 100% Bathurst caribou? If the people in charge of managing caribou have overseen the greatest wildlife crash in the history of North America, far exceeding even the great buffalo crash, why should these guys still be employed? Exactly which numbers have these guys gotten right? Which definition of a herd are we using today? Why are we allowing the harvest of Bluenose East caribou, when we were told they are down? Why harvest more wolves, when their numbers, according to ENR, have dropped with the caribou numbers. Why does ENR refuse to survey the Ahiak caribou, which are clearly calving on the traditional Bathurst calving ground? What happened to road closures and tag systems? What happened to the hundreds of thousands of dead caribou, claimed by ENR? What happened to ENR's earlier statements blaming climate change?"


Attached is a list of documents I would like to see produced. Given the nature of the new joint proposal, I am of the opinion that a new hearing must be held. Since this error is the fault of the Tlicho Government and the Government of the Northwest Territories failing to agree on an original joint proposal, I believe one or both governments should be held accountable for intervenor expenses. The \$25,000 per intervenor recently granted in Nunavut, for a far less important hearing, seems to me to be an appropriate starting point.

This hearing affects my ability to feed my family, and the personal loss of millions of dollars. Other interveners are there to fight for their aboriginal harvesting rights. Still other interveners are there to fight for their hunting rights, and the miscarriage of justice they see happening in the Northwest Territories. Ardour and passion eventually subside, and the bureaucrats that have created this mess go on with their everyday lives, receiving their government paychecks. These governmentsbureaucrats know, that without compensation, the interveners will eventually disappear, and they, the bureaucrats, and their agenda, will prevail.

A speedy hearing, back in 2007, was in everyone's best interest, particularly the outfitting industry. That industry, with the government delay of three years, for all intents and purposes, has already been destroyed. No industry can reasonably be expected to endure a government mandated 58% reduction in sales volume. That ENR goal, the destruction of non-resident hunting, has clearly been achieved. The urgency is no longer.

I hope you will all do your very best to seek the truth. If that means taking more time, so be it. A rush to judgment, at this point, serves no one.

Relevancy

All of the documents requested below may be relevant. It is impossible to know the exact extent of a document's relevancy, until it can be carefully examined. ENR has continually refused to produce requested documents and data, citing such excuses as "they are still in draft", "private correspondence", "In Press", etc. etc. These documents include, but are not limited to, critical collaring information, as well as research documents and data presented to the Alberta Research Council. Interveners have continually been promised a transparent process, by both the G.N.W.T., and the W.R.R.B. Interveners have no power to coerce these possibly critical documents from the G.N.W.T., but the W.R.R.B. does have such power. In order to ensure a fair process going forward, this intervener respectfully requests that the W.R.R.B. exercise its power, and insist on the production of these requested documents. This intervener then requests a reasonable period of time to examine all the produced documents, so that their relevancy may be properly determined.

Requested Documents and Data

1. Raw collaring data of all caribou animals since inception of the collaring program in 1996 including, all via individual animal and with assignment to herd and including the Bluenose, Bathurst, Ahiak and Beverly herds

- number of collared animals each year
- locations without deletions
- date of capture
- date of death/failure of collar
- reason for death or reason for failure
- age
- sex
- reproduction status
- assignment to herds
- location of animal when collared
- location of animal upon termination of functioning collar
- length of time on collared info
- identification of collared animals in surveys-which animals are included in ENR surveys
- all raw mortality information from collared and other animals
- calf survival raw data from 2005 and 2006 including video tapes (ENR biologists did not know how to identify yearlings)
- All ENR policies and documents regarding or in any way relevant to collared caribou, including but not limited to all emails internal and external, internal standards, ethics, correspondence with aboriginal groups over the years since inception of the collared caribou system
- All back up files of these collaring movement since 1996

- A description of how collared caribou information is recorded in the field and included in the computer system since 1996
- Computer back up system generation for the collared caribou information since 1996
- Security system in place for collared caribou system since 1996
- Authorizations for data control over the collared caribou system
- Weekly maps of caribou movements since 1996 as was available to the public in the past

2. Surveys

- All surveys, of all relevant herds (Bluenose East, Bathurst, Ahlak, Northeast Mainland, Beverly), from 2006 -2010.
- All reports given to outfitters regarding the status of the herds. In particular, the 2007 and 2008 Outfitter Updates.

3. Wolf and bear data

- all reports on wolf and bear abundance, levels of predation, and estimated harvest levels, since 1986.
- Any wolf collaring data, from Alaska or the Yukon, indicating the migration of wolves from those regions, into the NWT.
- Documentation of outfitter wolf harvest, and number of caribou saved annually, by this wolf harvest.

4. Alberta Research Council

- All correspondence, emails- notes of conversations etc with all officials at ARC and external biologists
- All drafts of the ARC report
- All amendments to the ARC report- via email, fax, phone etc.
- All comments received from other biologists regarding the ARC report, comments and comments that were included and not included in the final report or drafts
- All correspondence with ARC before and after they were hired to produce the report and attend the hearing, including 2009 and 2010
- All correspondence and drafts regarding draft terms of reference
- All correspondence between Larry Roy, Jason Fisher, Anne Gunn, John Nishi, John Nagy, John Boulanger and ENR and officials

- All payments from the GNWT and the Tlicho Governments to Mr. John Donihee and Dr. Anne Gunn, since 2005.

- total harvest by outfitters by sex and age of caribou and season
- All data regarding wounding rates, by resident, non-resident, and aboriginal harvesters

7. Caribou Harvest March 2010

- all documents, memos, records of conversations regarding the harvest in March of 50 animals including all documents related to ENR management of site and all photos of site
- all information obtained from this hunt

8. Community Hunts
